As it is now, I built my immigration detention facility nearly eight years ago and on average I'm paid about 6 million dollars per year for the detention. The legislature takes the Federal revenue each year, uses it for non law enforcement purposes, and underfunds my operating budget by millions each year. Following the attacks on the World Trade Centers it became increasingly clear that we needed to strengthen our partnerships at the local, County, State and Federal levels in law enforcement, to maximize resources, sharing equipment, intelligence, training, and participation in multi disciplined task forces. We cannot allow these partisan self serving legislators to undermine our ability to strengthen our public safety response to terrorism, illegal immigration, trans national gang activities, drug smuggling, and human trafficking. I am working to rally the Sheriffs to speak out and hoping to persuade many of them to become 287 G agencies. I will keep you posted as things evolve. My regards to Stephen and the team.
